AAUW Public Policy

In 2018, Nevada voters will elect our constitutional officers, namely, Governor, Lt. Governor, Attorney General, Secretary of State, Treasurer, Comptroller, State Senator, and State Assemblyman. Why does that matter? It matters because you are going to be exposed to candidates wanting your vote. It matters because now is the time to ask the candidates questions to find out what AAUW issues they will support, so you'll know who you want to give your vote.

To help you ask the questions about the issues that affect our families and communities, watch our newsletter for the next five months. You'll be given questions to ask in five different categories from AAUW's Public Policy Priorities along with what to listen for in candidates' rhetoric.

This month's questions center around **Gender Pay Gap**. On average, women working full time are paid about 80 cents for every dollar paid to men working full time. Over a lifetime of work (47 years), the total estimated loss of women's pay compared with men's is roughly \$700, 000 for a high school graduate, \$1.2 million for college graduate, and \$2 million for a professional school graduate. The pay gap is even larger for women of color. AAUW believes that pay equity and equal opportunity are a matter of simple fairness. While the legislative and executive branches have taken some steps to ensure pay equity, additional action is needed to provide more effective equal pay protections. AAUW advocates for strong pay equity legislation, targeted executive actions, clear regulations, and strong enforcement to protect employees and assist employers as they strive to follow the law.


Listen for the candidates' discussion of these terms:

Equal pay for equal work, wage, gap, wage/pay discrimination, Equal Pay Act, pay gap, fair pay, comparable worth

Ask the candidates these questions:

How would you address the pay gap between men and women? How would you address the pay gap for women of color and mothers?

Do you support passage of the Paycheck Fairness Act to close legal loopholes and improve the effectiveness of existing civil rights laws aimed at closing the pay gap between men and women?

Question: Profits from Pecan Sales help the Capital Branch fund local scholarships as well as other AAUW educational programs. How long has the Capital (NV) Branch been selling pecans?

Answer: Thanks to the inquiring mind of Lin Nary, on September 11, 1957 we know that a project was launched that "would require the cooperation and active participation of all members". On November 13, 1957, they announced that 120 pounds of pecans had been sold and \$60 was earned!

Question: How did our 2016 sales go?

Answer: In 2016, 558 pounds of halves were sold; and 606 specialty packages were sold – for a net profit of \$4,673.22!

Question: How will we do in 2017??

Answer: As noted in 1957 (60 years ago at the launch), it will depend on "the cooperation and active participation of all members." Thanks to Carolyn Kellogg and all the volunteers who sold pecans at the Carson High Craft Sale **AND TO ALL MEMBERS who are actively selling.**
