Public Policy

The Nevada Legislature has been very busy since opening day on February 6th. It was announced at our April 4th meeting that AAUW had narrowed our bill watch list to 14 bills out of the 1,002 that had been introduced to date. The major areas being watched include pay equity, minimum wage, paid family leave, affordable child care and human trafficking. As of the April 14th cutoff date, our watch list has been narrowed even further – only 10 of our bills survived the deadline requiring a bill to have passed out of the first committee. See the summary at the end of this article.

Work Smart Workshop

Seventeen student and community leaders participated in OUR first Work Smart Workshop on Saturday, April 8, 2017 at Western Nevada College. Sponsored by Partnership Carson City and our AAUW Capital (NV) Branch, the workshop was facilitated by two of our members, Dr. Jennifer Verive and Dr. Peggy Wozniak.

As many of you know, AAUW Capital (NV) Branch has been collaborating with Western Nevada College over the past few years trying to find an event that would get students involved and excited. We finally did it! Students from Western's Business program, CareerConnect, Associated Students of Western Nevada (ASWN), and the Latino cohort joined in with WNC staff, instructors, and representatives from Partnership Carson City, the United Latino Community, and our local AAUW Capital (NV) Branch to learn how to close the gender pay gap by



negotiating for a fair and equitable salary.

AAUW's WorkSmart workshop empowers women to negotiate their salary and benefits packages. The April workshop corresponded with a national campaign by AAUW to offer these workshops

across the country during the first week of April to recognize Equal Pay Day—the symbolic day when [women's earnings "catch up"](#) to men's earnings from the previous year.

AAUW Capital (NV) Branch is hoping to schedule additional workshops in the near future. Two more branch members are becoming facilitators. The work-


Daytime Book Group:

Questions? Answers!

AAUW'S 2017 NATIONAL ELECTION

Question: When does voting begin and end for the 2017 National Election?

Answer: Online voting begins officially on April 17, 2017. This is a change from previous noted timeline, to be in accordance with DC regulations. Online voting ends on June 15, 2017 at 9 p.m. EDT

Question: Can I request a paper ballot for the election?

Answer: Yes, you can request a paper ballot beginning on April 3, 2017. Request MUST be received by May 4, 2017 by the National office.

Question: Who is eligible to vote?

Answer: Eligible voters are all full members who have paid their dues by 9 p.m., May 16, 2017. AAUW Bylaws indicate eligibility is determined 30 days prior to the close of the vote.

Question: Why should I vote? It won't make a difference!

Answer: It is critical that ALL members vote. In fact, ONLY 1 out of every 8 eligible members voted in the last election. YOUR vote is YOUR VOICE!

Question: What are the issues for this election?

Answer: Amendments to the bylaws of the organization have been proposed that will change AAUW's membership eligibility. There are also proposed changes to AAUW's Public Policy program. AND, above all, we will vote for our new leadership.

Question: How can I become informed about the issues and candidates?

Answer: Your Spring Outlook will contain detailed information about the candidates, bylaws proposals, Public Policy Program Proposals and resolutions. You can also go online to the AAUW website at <http://www.aauw.org/resource/national-election/> for additional info.

Question: Will AAUW Capital (NV) Branch have a study session for members so we can hear the pros and cons and discuss among ourselves?

Answer: YES! We will be having a "National Voting Day" discussion on Tuesday, June 6, 2017 at 5:30 p.m. at our regular meeting place. More details on this event will be in the June newsletter.

Question: Will I be receiving any additional contact from AAUW about the 2017 election?

Answer: YES! You should have received an email from AAUW around April 17th – this email will have contained a unique, personalized link which will allow you to vote online without having to provide your member ID or voter pin. However, if you deleted that email, your Outlook magazine label has the information as well.
