We form opinions of one another within seven seconds of meeting and 93% of the messages people receive from us have nothing to do with what we actually say. Why? People watch your body language before they listen to what you say. Recent brain research helps us understand our conscious and unconscious actions and reactions, and an increased understanding gives us an advantage in making connections. A necessary part of leadership skills is the ability to be aware of, regulate, and control one's nonverbal behavior or body language. Our November program, Silent Signals, can help you be more trusting of your impressions, and be more confident in yourself and your ability to interact with others.

On Wednesday, October 10th, Shirley Hammon, JoAnn Carpenter, Nancy Stiles and I took advantage of the CTE tour provided by Amy and Candi. Superintendent, Richard Stokes, joined us for a good portion of the tour as well. It was reiterated that Carson High has a student enrollment of approximately 2300 students, 1800 of whom are enrolled in at least one CTE class.

We were able to observe an Engineering lab, a Photography class in session, Health Sciences class being trained in CPR, Culinary Arts lab making pies, a





Hydroponics lab, and the Media and Webdesign labs. And more! Shirley, JoAnn, Nancy and I agreed that this was nothing like our high school experiences. We also explored a number of

additional ways AAUW may be able to collaborate with Carson High and the students. Exciting times and opportunities!

What's done is done, so what next? Women's Votes!! The most powerful way to have our voices heard is at the polls! Between now and Election Day, let's start conversations about the issues that affect our families and communities. We need to ask tough questions, start the discussion, and determine where our candidates stand. Our branch involvement in the candidate forums with the League of Women Voters was a good beginning, but it can continue up until Election Day, Nov. 6.

Now we need to be asking the question, "Are you voting?". Elections are determined by voter turnout, and when women vote, we change the conversation. We create real change at the polls. Early voting starts Oct. 20.

AAUW Action Fund has released helpful resources for the 2018 election. Visit the AAUW website, www.aauw.org to access the AAUW Action Fund Voter Issue Guide and the AAUW Action Fund Congressional Voting Record with information on federal legislators' votes cast and bills they cosponsored. You'll find survey results on seven AAUW issues: 1) pay equity legislation 2) paid leave policies 3) access to affordable family planning 4) improve minimum wage 5) polities for affordable child care 6) more funding for CHIP & Medicaid and 7) empowering misconduct harassment victims to seek justice. Of the six legislators representing Nevada, four responded with 100% support, and two with 0% support on the above issues.

The Department of Education is expected to propose new rules that would significantly change Title IX protections for victims of sexual harassment and assault in schools. The announcement is imminent. so we need all hands on deck to fight back.

Plain and simple: students should be able to go to school free from sex discrimination. But U.S. Secretary of Education Betsy DeVos has already taken action to roll back protections for survivors of sexual assault under the law. The Department of Education has stated that it plans to change Title IX's regulations, which could weaken students' civil rights and federal enforcement of Title IX. And they've indicated the process could start as early as this month.
