

March 5th Meeting

Stacey Shinn, Nevada State Director for State Innovation Exchange (SIX), will be one of our speakers for the March 5th AAUW meeting at the Sheriff's Office starting at 5:00. SIX is a non-partisan organization that provides documentation to the Legislators regarding women's and other issues. Prior to SIX, Stacey spent eight years as a lobbyist in Carson City working to advance social, environmental, and economic justice policies. Stacey also worked as a counselor in the mental health arena and taught English abroad. She holds a Master in Social Work from the University of Nevada and proudly serves as a supervisor for future macro social workers. Stacey is the President of the Human Service Network and a Commissioner on the Access to Justice Commission. Stacey resides in Reno, NV with her cat named Cream Cheese. Stacey Shinn will provide a window into working with policy makers at the Nevada Legislation.

Our other speaker will be **Amanda Morgan**, a Nevada civil rights attorney, who will be discussing "Fund Our Future" which is currently part of a Bill Draft Request that will provide a new funding mechanism for Nevada schools that would address the needs of various student populations. This plan proposes to draft legislation that will transition funding to a cost-based formula which should provide funds for those activities that would provide the greatest benefit to the largest number of students. Amanda is currently the Legal Director for Educate Nevada Now.

We have begun our process to award our 2019 college scholarship funds. The WNC scholarship is chosen by the college after evaluating our criteria. Our recipients must attend college in Nevada and maintain an appropriate grade point average.

At the March meeting, I will have a list available for any members who would like to evaluate the applications and all members who expressed interest in our survey. Governor Steve Sisolak has announced a partnership with the [SANS Institute](#) to launch Girls Go Cyberstart and Cyber FastTrack in Nevada. The initiative gives young women in high school and college an opportunity to learn cyber security skills, discover their cyber talents, and explore a career in the field. The three Nevada high schools with the most participants will win awards of \$1,000, \$750 and \$500, respectively. At least 10 high school girls will each get \$500 scholarships to help them pay for college. “I am committed to ensuring that all young women across Nevada have access to the education and experiences that will prepare them for exciting careers in STEM fields,” said Governor Sisolak.

We have a unique opportunity to fulfill the advocacy commission in our AAUW Mission in that we are so close to our Legislature, and can advocate in person. Our other advantage is in having one of the best legislative websites in the nation. It allows you to participate in the comfort of your home. Some direction on how to access that website’s many features will be given at our March meeting.

Our Capital Branch Legislative Committee, made up of Caroline Panches, Nancy Stiles, Marty McGarry, Judy Welch, JoAnn Carpenter, and Tera Bisbee, met recently to organize for a better participation in this 2019 Legislative Session.

Our goal is to inform members of legislative issues that align with our AAUW Public Policy during the 2019 Legislative Session, and encourage their legislative participation. Our task is for interested branch members to attend hearings, support or oppose certain bills on the [Legislation Website](#), contact their representatives by phone or twitter, and visit representatives in their offices presenting the stand taken by AAUW on an issue. A sign-up sheet will be available at the March meeting for you to indicate your willingness to participate. The Legislative Committee will then compile an email group with those names for the purpose of sending emails for “action alerts” on bills in the following categories: Pay Equity, Paid Leave, Minimum Wage, Affordable Child Care, and Public School Funding.

This is our opportunity to fulfill the advocacy piece in our AAUW Mission: “To advance equity for women and girls through research, education, and advocacy.” Please

join us in doing so at this opportune time during our 2019 Legislature Session.

In addition, please continue to advocate on the “Two-Minute Activist” under “Take Action” on our AAUW website, [aauw.org](#), for Federal Legislative issues found in our AAUW Public Policy. At present, there is a need to advocate for the Paycheck Fairness Act and Raise the Federal Minimum Wage. The website makes it so easy. With a click, they will do it for you.

Grassroots Lobby Days

Grassroots Lobby Days comes with every Legislative Session, and this year it comes on March 31 and April 1. Sponsored by the Nevada Women’s Lobby, these lobby days provide you with training and an opportunity to lobby with others. Grassroots Lobby Days participants will

- learn the Nevada legislative process and how to influence it;
- learn about current Nevada issues affecting Nevada’s women and families;
- meet other Nevadans with similar concerns;
- meet your Nevada senators and assembly members;
- attend legislative committee hearings and floor sessions.

You don’t want to miss this! It is well worth the time and money! There is limited space, so you’ll need to register as soon as possible to reserve your place. Go to [nevada-womenslobby.org](#) to register. You can participate for one day or for two. You can also choose to order breakfast, lunch, and dinner or not. The members of the senate and the assembly will attend the dinner, allowing you a chance to meet them personally. Sunday will have excellent speakers, and an opportunity to network with others with similar values. Monday will be another opportunity to meet senate and assembly members, and a chance to use what you learned on Sunday. You’ll really enjoy this, and you will be providing a service by advocating for AAUW issues that are important to women and to families.
