Yes, you may. But please let Caroline Panches know you plan to attend so we can ensure seating capacity. The meeting is on June 12th at 1:00PM in the board room of Partnership Carson City, 1925 N. Carson St., Carson City. The purpose of the meeting will be to determine some goals and the calendar for the upcoming years. The individuals who served in positions for the 2018-19FY will also be invited to participate.

According to our policies and procedures, board meetings are to be held a minimum of three times a year. We typically meet in June (end of the fiscal year) to evaluate the last year and also to identify goals for the upcoming year. We meet again in September or October to finalize our goals and calendar. We meet again in January to determine what administrative items might need to be addressed (policies & procedures and bylaws) at the April business meeting and to begin preparing for the next year's budget. We are allowed to have additional meetings should the need arise. 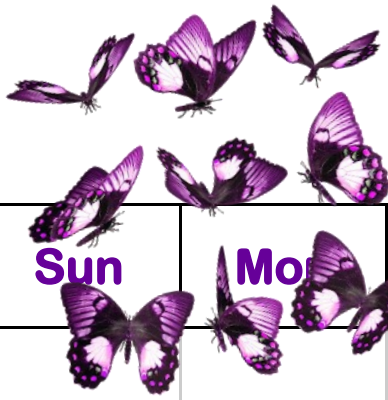
