Blockchain technology is affecting our lives and was a hot topic in the 2019 Legislative Session. How blockchains are being used and how fast their use is spreading is more important than how it technically works, so our program should be of interest to everyone.


Blockchain technology was created for bitcoin by unknown developers. This technology creates a secure, transparent and permanent ledger that is not kept in one place like traditional databases, but stores data on several servers and is controlled by a network of users who agree on the content.

Blockchain technology is becoming widely used for financial services, video games, online music distribution and more. IBM and Walmart are performing trials for supply chain monitoring. You do not need to know technically how blockchains work to know how they are changing data storage and affecting our lives.

Guest speaker Sena Loyd, a senior research analyst with Blockchain LLC, leads research efforts for projects supporting Blockchains' product development. A graduate from San Jose State University's Master in Library and Information Science program, she has worked for the Nevada Department of Transportation as a research librarian and the Carson City Library as its technology trainer, @Two Digital Learning Center Manager, and most recently as the library's director. Sena was named Nevada Library Association's 2017 Librarian of the Year.
