PUBLIC POLICY

Co-chair Janice Noble reminded members to sign up for the AAUW Two-Minute Activist and use it to let Congress and Senators know of support for the ERA. With Virginia, 38 states have now ratified the ERA but the issue is that ratification has gone beyond the deadline. There are resolutions introduced in both the House and the Senate to extend the deadline and another to allow ratification to start over again. Meanwhile, three states have sued to block the ERA on the basis of reproductive "rights" - by which they mean to block rights. Janice passed out AAUW's 2020 Gender Policy Agenda, which outlines our priority issues for the 2020 election season, policies which AAUW would like to see implemented.

PROGRAM

The speakers this evening are Joetta Brown from Nevada Commission for Women and Florence Phillips for ESL In-Home Program. Joetta Brown was the first speaker, reporting that Nevada has now joined the National Association for Women. The Commission is made up of 10 Commissioners with a goal of "Advance Women Toward Full Equality in All Areas". Currently they are working from a survey conducted through the Secretary of State of Nevada businesses and women's roles.

Florence Phillips gave a robust presentation on ESL In-Home Program of Northern Nevada. Her program has been in operation 16 years this month and was recognized as a CNN Hero. Statewide there are 254 tutors with 480 students; in Carson City there are 34 tutors with 84 students, 92% Hispanic with other learners from all over the world. But – there are 300 locally and 900 statewide on the waiting list and 7/8ths of them are women. The program also offers classes for citizenship and has funds to help pay fees for the application which will soon be \$1,140. The program also offers GED preparation, for both ESL and English speakers, and there is a computer literacy program. The program is funded strictly by donations and grants as a 501(c)3.

The March program topic is Criminal Justice.
